New Businesses in the JEDD

- Liberty Center: As new tenants open, JEDD info is being distributed. We continue to monitor and get in touch with the new tenants as they're announced.
 - New tenants open at LC: Sea Love Candles, Warby Parker
 - Firebirds Grill is under construction next to Shake Shack
 - Outlot building also under construction along Liberty Way – 2 or 3 tenants expected
- Freedom Pointe –Relay 129 apartments will be under construction soon. Stock Yards Bank is under construction. Zoning approval granted for E+O Kitchen, El Rancho Grande, Zaxsby's and a coffee shop – final plans anticipated in 2025.
- Early 2025, Cincinnati Children's announced a significant expansion to its Liberty Campus. A new, 4-story medical office building will be built along with an addition to its existing facility.
